

# Terms & Conditions – “Design Your Own Whirl” Giveaway

## 1. Organizer

This giveaway is organized by Scheepjes, based in the Netherlands.

## 2. Rules

1. Participants can use a maximum of 6 different colours in their Whirl Design.
2. Participants will give their Whirl design a name.

## 3. Eligibility

1. Participation is open to individuals aged 18 and over.
2. Employees of De Bondt B.V. and parties directly involved in this campaign are excluded from participation.
3. Participation is free of charge and does not require a purchase.

## 4. Campaign Period

1. The giveaway runs from May 5 2026 to June 2 2026.
2. Entries submitted outside this period will not be considered.

## 5. How to Enter

1. Participants are invited to design their own Whirl colourway following the campaign guidelines, they will fill in the colouring page in the Instagram post and post it with #Whirl10Years

## 6. Entry Requirements

1. Designs must be original and must not infringe on any third-party rights.
2. By entering, participants confirm they are the creator of the submitted design.
3. Entries must not contain inappropriate, offensive, or harmful content.

## 7. Selection and Judging

1. Winner(s) will be selected by a Scheepjes jury based on creativity, originality, and feasibility.
2. The decision of the jury is final and no correspondence will be entered into.
3. It can take up to 8 months after closing the giveaway for the final product to be ready.

## 8. Prize

1. Winner(s) will receive their design in 3 regular Whirls and 3 Cotton Whirl variants.
2. Prizes are non-transferable and cannot be exchanged for cash or alternatives.

## 9. Winner Announcement

1. Winner(s) will be announced via Instagram.

2. If a winner does not respond within 1 week, Scheepjes reserves the right to select an alternative winner.

## **10. Intellectual Property**

1. By submitting an entry, participants confirm that their design is their own original work and does not infringe upon any intellectual property rights, including but not limited to copyrights, trademarks, design rights, or other proprietary rights of third parties.

By entering the giveaway, participants grant Scheepjes a non-exclusive, worldwide, royalty-free, perpetual licence to use, reproduce, adapt, publish, and display the submitted designs for marketing, promotional, and communication purposes across all media channels, including but not limited to social media, websites, print materials, and exhibitions.
3. Scheepjes may edit, adapt, or format submitted designs where necessary for presentation or promotional use, while respecting the original concept of the design.
4. If a submitted design is selected for production, Scheepjes reserves the right to further develop, modify, and technically adjust the design to meet manufacturing requirements. In such cases, additional agreements may be made with the selected participant regarding production, crediting, and any further usage.
5. Participants agree that Scheepjes may mention their name or social media handle in connection with their design for promotional purposes, unless explicitly requested otherwise.
6. Scheepjes is not obliged to use, produce, or commercially release any submitted design.
